        - (1) June summer school was a huge hit with the BAK students. We had some great experiences in the community and look forward to the August session.
        - (2) The July session of summer school is off to a good start and kids are enjoying attending swimming lessons during summer school.
      - b) Recently, a member of the Family Resource Center left for a new job in Cedar Rapids, leaving Prairie du Chien with no one in the area with anger management certification. The closest place is Center Point Counseling in Viroqua. The training cost for this anger management counseling is approximately \$595 and it is available via DVD's and online. The school district is splitting the cost for the training of Tracy Morovits-Feye with Crawford County so that both entities can use her as a resource.
