- VIII. BOARD APPROVAL OF FINAL BUDGET
 - A. Energy Efficiency Exemption
 - Resolution to exceed the revenue limit under s. 121.91 (4) (o), Wis. Stats., on a non-recurring basis (one year) by an amount the district will spend on new energy efficiency measures and renewable energy products for the 2015-2016 school year.
 - 2. Enter into a performance contract with CESA 10 in keeping with Wis. Stat. sec. 66.0133 to access a Revenue Limit Exemption for Energy Efficiency for an amount stated in the above resolution.
 - B. BE IT RESOLVED, that the Prairie du Chien Board of Education approves the 2015-2016 fiscal year budget and property tax rate.

Motion by Devan and second by Christine to approve amended budget (1,406,799 debt service; 538,990 energy efficiency) and set property tax 'all fund tax levy' at 5,250,867 at a 10.66 Mil Rate; passed unanimous with all in favor.
